#### **About the Position:**

The Planning & Zoning Director performs a variety of cvomplex managerial, professional, and administrative duties, including overseeing planning, zoning, and land use code enforcement for Grand County. This position provides general supervision to Grand County Planning and Zoning staff, manages all aspects of Planning and Zoning activites, develops and implements poilicies and procedures, and oversees the department budget. Additionally, the Planning and Zoning Director is responsible for preparing, maintaining, updating, and implementing Grand County's General Plan, coordinating with other agencies in processing development applications, and drafting requests for proposals for community and economic development projects. Additional tasks related to overssing and managing the operations of the Grand County Planning Department are required.



#### **Essential Functions:**

- Technical review of development applications, site plans, and preliminary plats.
- Distribution of applications to appropriate agencies for review.
- Oversight of Staff Reports presented to the Planning Commission and County Commission.
- Make recommendations of amendments to policies and procedures, and draft amendments and ordinances.
- Coordinate with County Attorney for legal reviews.
- Management of Planning & Zoning operations and staff.
