*The committee will discuss draft legislation that modifies the definition of incremental value to include project areas created under Title 11, Chapter 58, Utah Inland Port Authority Act; Title 63H, Chapter 1, Military Installation Development Authority Act; and Title 63N, Chapter 1, Part 5, New Convention Facility Development Incentives.*

**9. Sales and Use Taxation of Fuels**

*Current statute provides for different tax treatment for residential, commercial, and industrial uses of fuel. The committee will receive a presentation and discuss situations where a property may receive fuel through a single meter but have more than one type of use of the fuel at that location.*

**10. Sales and Use Taxation of Fuels Used in Condominium and Short-term Rentals**

*The committee will receive a presentation and discuss whether the use of fuels in condominiums that are in a rental pool or short-term rental properties should be considered residential or commercial use.*
